

Privacy Policy

KARNANI GROUP of companies (that is, our subsidiary(ies), our ultimate holding company and its subsidiary(ies)); ("we", "our", "us") are committed to protecting and respecting your privacy. This Privacy Policy (together with our terms of use and any other document(s) referred to on it) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By visiting www.Karnanibuilders.com; and/or www.ambikacity.com or any other of our website(s) / mobile application(s) or platform(s) to which this Privacy Policy applies (our sites") or otherwise providing us with information you are accepting and consenting to the practices described in this Privacy Policy.

We May Collect And Process The Following Data About You:

i) Information you give us. You may give us information about you by filling in form(s) on our sites, or by submitting your Resume, or by corresponding with us by phone, e-mail(s) or otherwise or, by you interacting with any of our business associate(s), vendor(s) or contractors (including estate agent(s), sales personnel and our professional advisor(s)) engaged on our behalf. This includes information you provide when you register to use our sites, subscribe to our service, e-mail us, arrange property viewing(s) with us, request brochure(s) from us, complete enquiry form(s), provide your Resume and when you report any concern or issue with our sites. The information you give us may include your name, address(es), e-mail address(es), phone number(s) and any other information relevant to your enquiry or request for information or service(s) which we may request and you may choose to provide to us from time to time.

ii) Information we collect about you. We may automatically collect: technical information, including the IP address, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform; and information about your visit, including the full URL clickstream to, through and from our sites; material(s) you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information, and methods used to browse away from the page and any phone number used to call our customer service number.

iii) Information we receive from other sources. We may receive information about you if you use our sites or the other service(s) we provide. In this case, we will have informed you when we collected that data that it may be shared internally and combined with data collected on our sites. We also work closely with third parties (including, for example, business associate(s), contractors in technical, payment and delivery services, advertising network(s), analytics provider(s), search information provider(s), credit reference agency(ies)) and may receive information about you from them.

We Use Information Held About You In The Following Ways:

i) Information you give to us. We will use this information: to carry out our obligation(s) arising from any contract(s) entered into between you and us and to provide you with the information and service(s) that you request from us relating to the project(s), property(ies), venture(s) or opportunity(ies) detailed on our sites or otherwise notified to you; to provide you with information about other good(s) and/or service(s) we offer that are similar to those that you have already purchased or enquired about; to provide you, or permit selected third party(ies) to provide you, with information about opportunity(ies), good(s) and/or service(s) we feel may interest you. If you are an existing customer, we will only contact you by e-mail, SMS, telephone or your preferred method of contact if different, with information about opportunity(ies), good(s) and/or service(s) similar to those which were the subject of a previous sale or negotiation(s) of a sale to you. If you are a new customer, and where we permit third party(ies) to use your data, we (or they) will contact you by e-mail, SMS, telephone or your preferred method of contact if different only if you have consented to this.

ii) Information we collect about you. We will use this information: to administer our sites and for internal operation(s), including troubleshooting, data analysis, testing, research, statistical and survey purposes; to improve our sites to ensure that content is presented in the most effective manner for you and for your computer/ lap-top; to allow you, when required, to participate in interactive features of our service; as part of our efforts to keep our sites safe and secure; to measure or understand the effectiveness of advertising we serve to you and others, and to deliver relevant advertising to you; to make suggestions and recommendations to you and other users of our sites about good(s) and/or service(s) that may interest you or them.

iii) Information we receive from other sources. We may combine this information with information you give to us and information we collect about you. This includes but is not limited to information we receive from our sales agent(s). We may use this information and the combined information for the purposes set out above (depending on the types of information we receive).

DISCLOSURE OF YOUR INFORMATION

A) We may share your personal information with any member of our group, which means our subsidiary(ies), our ultimate holding company and its subsidiary(ies).

B) We may share your information with selected third party(ies) including, where applicable:
i. Business associate(s), vendor(s) and contractors (including, but not limited to, estate agent(s), sales personnel and our professional advisor(s)) for the performance of any contract

or any potential contract we may enter into with them or you, or in relation to any ancillary requirement(s); ii. Advertiser(s) and advertising network(s) that require the data to select and serve relevant advert(s) to you and others; and; iii. Analytics and search engine provider(s) that assist us in the improvement and optimisation of our sites.

C) We may disclose your personal information to third parties: i. If we sell or buy any business or asset(s), we may disclose your personal data to the prospective seller or buyer of such business or asset(s); ii. If Karnani Group or substantially all of its asset(s) are acquired by a third party, your personal data will be one of the transferred assets; and iii. If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreement(s); or to protect the right(s), property(ies), or safety of Karnani Group, our customer(s), or others. This includes exchanging information with other company(ies), entity(ies) and organisation(s) for the purposes of fraud protection and credit risk reduction.

D) We may share your non sales related information such as Cookies, Email IDs, Phone number etc to external party(ies). But, we do not share your sales related information such as PAN Card No, Credit / Debit Card details, Preference details with the external party(ies).

WHERE WE STORE YOUR PERSONAL DATA

A) The data that we collect from you may be transferred, stored and processed by staff or personnel who work for us or for one of our vendor(s) or one of our group companies.
